Law Enforcement Agency of the Year Award

Law Enforcement Agency of the Year Application

Summary:

This award will be given to a law enforcement agency in North Carolina. The agency nominated must have an active membership with the North Carolina Police Executives Association. The North Carolina Police Executives Association is looking for an agency which has pioneered an innovative program, policy or concept not knowingly used elsewhere, to further the professionalism of Law Enforcement, and/or the service to citizens.

Criteria:

The award is based upon innovative program(s), policies, or technology, not knowingly used elsewhere. Weight of the nomination is increased with the level of risk taking (without sacrificing ethics or safety), and new innovation differing from long standing tradition.

The weight of the nomination increases with the commonality of the problem for which the program, policy or concept was implemented. This award honors agencies for programs that demonstrate the principles of community policing, problem solving strategies and/or and strengthen community trust. The nominated agency must be a NCPEA member agency in good standing at the time of the program, policy and the award presentation.

PROCEDURE FOR NOMINATION and SELECTION

1. These nominations should be submitted electronically to info@ncpea.org or mailed to P.O. Box 58201, Fayetteville, NC 28305. To nominate a person, please complete the NCPEA Law Enforcement Agency Award Nomination Application and:
 - A narrative outlining the following criteria:
 - The agency's service to the community, and
 - The agency's accomplishments as a law enforcement agency in the local community (such as new innovative program, best practices, comprehensive policy and procedures.
2. The submission of supporting documents is encouraged, but not required, including but not limited to:
 - Photos or copies of photos.
 - Printed documents such as newspaper or magazine articles or newsletters, awards from community groups, etc.
 - Press releases, reports or other documents.
 - Positive Publications for the agency.
 - Links to any of the above will suffice if they provide sufficient online documentation, but please provide a very brief summary.
 - PDF, Word or jpeg files are accepted.
3. Deadline for nominations is March 1 of each year. The Board of Officers will announce the finalists for the award by June 1. In the event that a list of finalists is announced, these will be publicized to the membership.
4. The award will be presented during the Installation Banquet of the new Presidents during the annual summer training conference in July of the current year. The agency is required to attend the banquet at the police department's expense. The banquet will be held on July 16, 2019 in Wilmington, North Carolina.
