POLICE EXECUTIVE OF THE YEAR AWARD

The NCPEA is presenting the "Police Executive of the Year" award to an active member of the Association. Nominations may be made by anyone wishing to nominate a police executive of a law enforcement agency/department who is in good standing and a member of the association. A Police Executive is defined by NCPEA as a sworn law enforcement employee who holds the status of a **sworn supervisor** in any law enforcement/public safety entity.

Members of the NCPEA Executive Board Officers are excluded from consideration for this award in the year in which they are on the Board. Prior past Board Officers are eligible.

Nominations must made by forms provided by the Association. The Board of Officers will select the Police Executive of the Year from the list of nominees.

PROCEDURE FOR NOMINATION and SELECTION

- 1. These nominations should be submitted electronically to info@ncpea.org or mailed to P.O. Box 58201, Fayetteville, NC 28305. To nominate a person, please complete the NCPEA Police Executive Award Nomination Application and:
 - A narrative outlining the following criteria:
 - o The member's service to the community, and
 - o The member's accomplishments as a law enforcement administrator

Information may include details from a nominee's entire career, and some of the service/activity should be from the previous year.

- 2. The submission of supporting documents is encouraged, but not required, including but not limited to:
 - Photos or copies of photos.
 - Printed documents such as newspaper or magazine articles or newsletters, awards from community groups, etc.
 - Press releases, reports or other documents.
 - Publications by the nominee.
 - Links to any of the above will suffice if they provide sufficient online documentation, but please provide a very brief summary.
 - PDF, Word or jpeg files are accepted.
- 3. The Executive Director will forward all nominations to the Board of Officers for their review.
- 4. The Board of Officers may announce the finalists for the award by June 1. In the event that a list of finalists is announced, these will be publicized to the membership.
- 5. The award will be presented during the Installation Banquet of the new Presidents during the annual summer training conference in July of the current year. The recipient is required to attend the banquet at his/her own expense or the police department's expense. The banquet will be held on July 16, 2019 in Wilmington, North Carolina.
